

## Heart Rhythm 2025 Presenter Letter of Agreement

- I grant to Heart Rhythm Society ("HRS") a royalty-free license to use, reproduce, and distribute my presentation (including, but not limited to, the content, information, and materials contained in such presentation) (referred to hereinafter as the "Presentation") at Heart Rhythm 2025, (the "Program") in any way in the future, with appropriate attribution to me.
